The city clerk read a communication from Railroad Commissioner Chas. R. Whitman, stating that an order had been entered requiring the T., A. A. & N. M. R. R. to maintain safety gates at the crossing of Miller avenue and Washington street, a flagman at Liberty street and electric alarm bell signals at South Main and Pontiac streets. Received and filed.

WHEREAS, In the opinion of the Council the grade on north Fifth avenue between Beakes and Summit streets ought to be changed and fixed and established to the end that such street may be suitable for traffic with wagons and other vehicles, therefore,

RESOLVED, That it is hereby ordered that the grade of north Fifth avenue between Beakes and Summit streets be changed from its present grade and fixed and established so that the grade along the center line of said street at and between the streets aforesaid shall be as follows, that is to say:

The elevations given being above the

official City Datum, viz:

At the south line of Summit street seven hundred seventy-nine and 60-100 feet:

At a point two hundred and fifty feet southerly from the south line of Summit street eight hundred one and 10-100 feet:

At a point three hundred and seven: ty-five feet southerly from the south line of Summit street eight hundred four and 10-100 feet.

At a point five hundred and seventyfive feet southerly from the south line of Summit street eight hundred one and 10-100 feet,

The said elevations being on and along the center line of said avenue and the balance of the roadway to conform thereto, and the grade lines to consist of straight lines between the several points or stations stated.
