COUNCIL CHAMBER, ANN ARBOR, March 14, 1892.

Adjourned session.

President Cooley being absent, the Council was called to order by City Clerk Miller.

Roll called. A quorum present.

Absent—Ald. Mann, Herz and President Cooley.—3.

On motion of Ald. Wines, Ald. Hall was elected president pro tem.

SPECIAL ORDER.

Chairman Hall stated that the first business in order was the consideration of laying out, widening and straightening Summit street, which was continued from March 7th meeting to this meeting. No objection being made, Ald. Fillmore offered the following resolution:

Whereas, Application having been made to this Common Council to lay out, widen and straighten a certain street called Summit street, west from Main street hereinafter described, and due notice of the pendency of such proposed improvement having been duly given to all persons who are interested in the lands and tenaments required therefore, and all persons appearing having been heard, and due consideration thereof having been had and it appearing therefrom that it is necessary to take and acquire certain lands therefor. Therefore, be it

Resolved, and it is hereby ordered

and determined that the said street called Summit street be, and the same is hereby ordered laid out, widened and straightened and to be four (4) rods in width west of Main street in the city of Ann Arbor, described as follows, to-wit: From Main street westerly to the angle of Summit street, next east of Grove street, the center line of which when laid out, widened and and straightened shall be a straight line between the stone, brick or iron monument which now marks the intersection of the center line of Summit street east of Main street with the line of monument on north Main street in said city, and a like monument which marks the angle in Summit

street, lately called High street, next east of Grove street in said city.

Which resolution prevailed by a yea and nay vote as follows:

Yeas—Ald. Wines, Martin, Alimendinger, Fillmore, O'Hearn, Ferguson, Taylor, Rehberg, Hall, Kitson—10.

Nays-None.

By Alderman Allmendinger:

Resolved, That the President appoint a committee of three, who, with the City Attorney, obtain and report at the next meeting what sums of money will be necessary to obtain the title to the land required for the laying out, widening and straightening Summit street westerly from Main street.

Which resolution prevailed by a yea and nay vote as follows:

The chair appointed the following committee: Ald. Martin, Allmendinger and Kitson.

By Ald. Rehberg:

Resolved, That Ald. C. Frank O'-Hearn, Louis P. Hall, and City Clerk W. J. Miller be and they are hereby appointed and elected to be members of and to constitute the Board of Election Commissioners in and for the City of Ann Arbor, for the city election to be held in and for said city, on the Fourth day of April, A. D. 1892. That such persons above named shall have and hold such office for and during such time and term as shall be necessary to fully discharge all of the duties pertaining to such office in the conduct of such election, and the said Board of Election Commissioners are hereby charged with the duty of doing all of the things enjoined upon City Boards of Election Commissioners under the general law of this State.

Ald. Wines moved to amend by adding the names of John R. Miner and Samuel W. Beakes, which amendment prevailed. Whereupon, the resolution

as amended was passed by year and street commissioner's annual report. nays as follows:

To the Common Council:-

In obedience to the resolution of your Honorable Body, we do hereby submit plans and specifications for culvert on Hill street now on file in the City Clerk's Office, the same is hereby transmitted, and that we estimate the sum of four hundred dollars will be necessary to build the same.

We further recommend that culverts be or-dered constructed at Fifth street 2d ward, Felch street 3rd ward, over Allen's creek and Mill

race.

Also that an appropriation be made for tiling Detroit street, from Division street north to Mr. Weidlich's property, and that an appropriation be made for grading the point between Beakes and Detroit streets.

We also submit in obedience to the resolution of your Honorable Body, Mt. Elliott Ave. as a sample street sign, and would recommend the adoption of such signs for the City, and would ask for an appropriation of \$500 for such

signs.
