# COUNCIL PROCEEDINGS.

COUNCIL CHAMBER. (ANN ARBOR, June 16th, 1892.)

Special meeting.

President Cooley being absent, the Council was called to order by City Clerk Miller.

Roll called. A quorum present.

Absent-Ald. Wines, Fillmore, O'-Mara, Rehberg, Taylor, and President Cooley-6.

On motion of Ald. Kitson, Ald. Prettyman was elected president pro tem.

The call of the special meeting having been read by the Clerk, the following business was transacted:

To the Common Council:

The Board of Public Works, to whom was referred by his honor, the Mayor, the present condition of First street, respectfully report that we find that the Toledo, Ann Arbor and North Michigan Railroad Company are desirous of constructing, for the conveyance and accommodation of their patrons, a spur track along their property which fronts on First street, and desire leave to cross First street along the west side of their main track, and also Williams street along First street in so doing, and we would respectfully recommend that said railway be granted such permission on certain conditions. as follows:

1st. That the Toledo, Ann Arbor and North Michigan Railway Company do forthwith construct a plank side-walk along the east side of First street adjacent to all of their property, including their original right of way across First street.

2d. That they extend the culvert on First street westerly to the west line of First street, by 24-inch tile, to be laid double and side by side, and covering

the same to grade of street.

3d. That the crossing of said spur track be at the present grade of said streets respectively, the city reserving to itself the right to change the grade of each of said streets, and the said Company to conform to such change by placing their said spur track at all times at established grade.

4th. That such spur track be laid wholly on Company ground and out of First street as claimed by the City, and

as lately surveyed by the City Engineer, except where said spur track crosses said First street.

5th. That at crossing of both First and William streets, the company to construct plank crossings,

width of each street.

6th. That construction and extension of culvert, the sidewalk and each road crossing be under the direction of and all work and material used, to be to the satisfaction of the Street Commissioner.

7th. And the said Board further reports that the said Railway has already removed its track from and along First street to its own grounds within the time and as heretofore ordered by your honorable body, and to the entire satisfaction of this entire Board.

Regular meeting.

Minutes of previous meeting approved. COMMUNICATION FROM THE MAYOR.

A communication from the Mayor with a subjoined petition of residents of the 3rd and 4th wards of the City of Ann Arbor praying for the changing of the name of the street called "North Street" to "Kingsley Street," and a letter accompanying the same from the Hon. Alpheus Felch relating to the subject matter of said petitton.

Referred to Street Committee.

A claim of Floronce V. Smith, of the Village of Schoolcraft, Mich., setting forth that on the tenth day of October, 1891, she sustained a very severe injury to her right limb, by a defective sidewalk on East Ann St., and that she is willing to accept by way of compromise, the sum of \$5,000, provided she is not compelled to commence suit.

On motion said claim was referred to City Attorney and Sidewalk Committee.

A petition signed by Geo. P. Stauch and twenty-three others, residents and property holders of the 3rd ward asking for an electric light at and near the corner of Brook and Summit streets.

Referred to Lighting Committee.

A petition was received from the property owners on Gott street, 3rd ward asking for the extension of 6 inch water main from Miller ave. along Gott st. to the corner of Gott and Summit streets and placing a fire hydrant at such intersection.

Referred to Water Committee.

A petition signed by Joseph Geromiller and twenty-four others, residents and property holders of the 3rd ward asking for an electric light on the corner Gott and Summit streets.

Referred to Lighting Committee.

A petition signed by Eliza C. Bird and nine others, residents and property holders of the 6th ward, asking for the extension of a six inch water main from Ann street, south on 14th st. to the corner of 14th and Washington streets, and placing a fire hydrant atsuch intersections.

Referred to Water Committee.

To the Common Council:-

The Board of Public Works respectfully recommend, that it is a necessary public improvement, to at once build a cement sidewalk

in front of the Engine House on Huron street the Board therefore asks your honorable body to appropriate the sum of \$160 to build said sidewalk.

Ald. Martin moved that the bond be approved, which motion prevailed.

Ald. Martin moved that the motion by kind or nature in the saloons of this city, removed within ten days from this date. which the communication of the board of public works at the last special meeting was laid upon the table, be reconsidered, which motion prevailed.

The report being again read, Ald. Martin moved that the recommendation be in all things approved, accepted and adopted.

Ald. Martin moved as an amendment that the fifth condition of the report be amended so as to read:

5th. That at the crossings of Liberty, First, William and Jefferson streets, the company to construct plank crossings the full width of each street.

Ald. Wines moved that the whole matter be referred back to the board of public works, which motion prevailed.
