Report of Street Committee.

Ann Arbor, Mich., July 20, 1903. To the Common Council.

Gentlemen: Your committee. whom was referred the matter of reservicing Detroit street, would respectfully report that the street is in very bad condition and ought to be broken up, redressed with new broken stones and rolled with the steam roller.

We would further recommend that Broadway street be regraveled from Bridge to Moore street and that Wall street be narrowed down from its present driveway, which is about fifty feet (50), to a thirty-foot (30) driveway, and the same to be graded and graveled so that the water will drain its full length from Broadway street to the Bridge, crossing the river on Wall street.

We would further recommend that the stone culvert on Mill street be put into good repair.

Your committee made a personal inspection of the culvert on North Main street in front of J. Clark's house, and found the same in a very dangerous condition, through the freshets from the past year, the earth has been washed out from under the footings so that the walls are liable to collapse at any time; we would recom-

its place.

We would further recommend that East Catherine street and Clark street be properly graded and graveled.

We recommend that the above work be executed as soon as possible by the Street Commissioner under the direction of the Board of Public Works.

We further recommend that immediate steps be taken by the Board of Public Works in having our streets put into better condition. We recommend that a team be placed into each ward, whose business it will be to load his wagon with gravel in the morning in starting out to work, drive along the streets and fill all such depressions in the streets and continue to do so until he has gone over his entire ward into which he has been placed.

As soon as our streets have been gone over according to these directions, we would recommend that the Board of Public Works be asked to carry out the plans as suggested by the street committee several months ago in reference to districting the city and placing a man into each district.

We would further beg leave to report that in their judgment would think that it is absolutely necessary for this city to make arrangements of some kind whereby all property belonging to the city, such as sewer pipe, plank, brick, stone, and everything along this line could be properly stored, and also provide for a suitable place for our street scrapers, snow-plows and road-rollers, in fact, such a place where anything belonging to the city could be cared for and kept track of.

Your committee made a personal inspection of the old Tolbert lumber yard on Depot street, and would recommend that this property be purchased according to the option given by T. J. Keech, agent.

Garbage Committee's report:

Report of the Garbage Committee, L. D. Grose, Chairman.

To the Honorable, the President of the Common Council.

Your committee on the garbage question, after corresponding with several cities and gathering such information as possible upon the sub-

ject, begs leave to submit the following report:

We find that at such places as make any attempt at garbage disposal the following methods are employed, viz.: Dumping on waste land, in river, lake, or sea; turning over to renderingworks; and cremation.

As we have neither sea nor lake frontage, and as our river is entirely too small for the purpose, we cannot use this means of disposal. Waste land or other suitable dumping ground sufficient capacity is not available without long and expensive hauling; moreover, these dumping grounds are unsightly and unhealthful, a veritable nuisance, as those who know the various small dumping grounds in and about our city can testify. At Fitchburg, Mass., where this method has been employed, the public dump is complained of as a menace, and the city is being forced to some other means of disposing of its refuse mat-Similar reports from other places show like conditions; it would seem that as a sanitary measure the dumping ground must go, as the garbage must go from Ann Arbor.

Some idea of the expense of this method may be gathered from the fact that the city of Baltimore, with a population of five hundred thousand, pays \$200,000 annually for dumping its garbage. At this rate, it would cost Ann Arbor approximately \$8,000 annually to dump its garbage, provided it had a place to dump it.

The dump system is, then, out of the question, for we have no place for dumping; furthermore, sanitary and financial reasons stand in serious opposition to its adoption, even could suitable grounds be secured.

The next scheme of disposal is that of turning the refuse matter over to rendering-works. This plan is used at Boston, Mass., and several other cities; however, in each case a considerable portion of the garbage has to be dumped, as rendering-works can utilize only certain forms of waste, and the remainder has to be disposed of in some other manner.

It will be remembered that your committee some few weeks since submitted a report upon a conference with the manager of the Ann Arbor Rendering-Works concerning this sub-In this report we stated that they would be willing to set up a larger plant in case they should be the contract. But there awarded would be no great advantage to the city in making such a contract. fact, if a plant is to be established, it would be to the city's interest to build and operate the concern itself, for no company would set up and run such a plant for nothing; they would expect to pay for and maintain it, as well as make some dividend out of the profits accruing from their contract with the city. In other words, the city would be paying for the institution, maintaining it, and the company coffers, all for the doubtprivilege of hunting up means of disposing of the larger portion of refuse rejected by the rendering-works.

As this remainder cannot be dumped and so got rid of, there remains but to cremate it. This will necessitate the establishment of a crematory; and if we must have a crematory for part of our garbage anyhow, it would seem but the part of wisdom that we should have one of sufficient capacity to handle it all. The expense of cremation is far below that of dumping; and the modern equipments for the purpose render it a clean, sanitary, and rapid process, offending neither sight nor smell, and satisfactory in every sense of the word. As to expense, Atlanta, Ga., in 1899, with a population in round numbers of ninety thousand, cremated its garbage at a total cost of a trifle over \$105,000, including cartage and all attendant expenses. On this basis, Ann Arbor could cremate its garbage at an annual cost of \$2,300, a little over one-fourth of the cost of dumping.

For further and fuller discussion of the problem of cremation, your committee would respectfully refer you to the remarks of Dr. Heber Jones before the American Public Health Association, New Orleans, December, 1902, a copy of which is herewith submitted.

Of the crematories in use, made by the Dixon Garbage Crematory Co. of Toledo, Ohio, seems to be the most popular because the most satisfactory in its results. The U.S. Government has in operation five of these plants at the following points: Santiago, Cuba; West Point Military Academy, N. Y.; Fort Russel, Wyoming; Fort Warner, Mass., and Norfolk, Va., all of which are giving the most satisfactory results, as are those owned and operated by the municipalities of Wilmington, Del.; Fort Wayne, Ind.; Youngstown, Ohio, and Bridgeport, Conn. Copies of testimonials and statements from these several plants are herewith submitted; they speak for themselves.

Now as to cost of establishing a crematory of sufficient capacity to dispose of Ann Arbor's refuse, this company has submitted the following estimates:

building 9,000 Same, but with brick building. 10,000

These prices, of course, exclusive of site. Such a plant would be ample to meet not only the present requirements of the city, but those incident to the natural increase in population for many years to come.

Whatever system of disposal is adopted, some means of collecting the garbage is necessary. The best seems to be the can system, by which each house is provided with one or more cans, according to the number of inmates; the cans are collected at stated periods, empty ones being left in their stead. It is usual to charge a small fee, \$0.25 or \$0.30 per month, for such service. According to data furnished by the City Clerk's office there are in the city 3,343 houses; estimating that 30 per cent will not need the service because of location or other

reason, we have about 2,300 houses, each yielding a monthly revenue of \$3.00 annually. or means an annual income of \$6,900. From the estimate given above, it will be seen that this will give an annual profit of \$3,600. At this rate the plant will not only be self supporting, but will also have paid for itself in about three years, even putting up the \$10,-000 structure, which would prove the more economical, as the best is always the cheapest in the long run.

In view of these considerations your committee would respectively recommend that the council vote the establishment of a suitable garbage crematory and take such steps as may be necessary to that end.
