Gentlemen:—

The undersigned City Clerk begs to submit the following as the report of the proceedings of the Board of Review, having under consideration the review of the several sidewalks constructed by the Board of Public Works in the City of Ann Arbor at the expense of the Building Sidewalk Fund.

The Council sitting as such Board of Review in pursuance to its order and appointment for that purpose, met at the Council Chamber on Thursday, the 3rd day of November, 1904, at 2 o'clock-p. m. and due proof of the publication of the notice of the meeting filed.

The roll call of Aldermen being called and the quorum being found present, as follows: Ald. Gill, Douglas, Hutzel, Schlenker, Miller, Kearns, Sherk, Coon, Robinson, Fischer.—10.

The chairman duly elected for the

Board of Review, and the certificate of the Board of Public Works being presented, the Council entered upon the consideration of the same.
