To the Honorable the Common Council:

Gentlemen: Your committee to whom the matter of fire hydrants was referred respectfully recommend that a ten inch water main be laid from State street along Washington to Thayer and along Thayer to Huron street. We also recommend that an eight inch fire hydrant be placed on State street near center of block between Huron and

Washington streets, and one near center of block on Washington street, between State and Thayer streets. One on corner of Thayer and Washington streets and one near center of block on Thayer street, between Washington and Huron streets. We further recommend that all fire hydrants on Main street between Catherine and William streets be removed and replaced with eight-inch hydrants.
