# AMENDMENT TO TITLE OF ORDINANCE:

AN ORDINANCE REGULAT-ING, RESTRICTING AND DIS-TRICTING THE LOCATION OF RESIDENCES, TRADES, INDUS-TRIES, BUSINESSES AND THE LOCATION OF BUILDINGS DE-SIGNED FOR SPECIFIED USES. AND ESTABLISHING THEBOUNDARIES OF DISTRICTS FOR THE SAID PURPOSES; ES-TABLISHING HEIGHT AND AREA DISTRICTS: REGULAT-ING AND DETERMINING THE AREA OF YARDS, COURTS AND OTHER OPEN SPACES SUR-ROUNDING **BUILDINGS:** TOREGULATE AND LIMIT THE  $\mathbf{OF}$ DENSITY **POPULATION:** PROVIDING FOR THE ESTAB-LISHING OF SET BACK LINES AND PROVIDING A PENALTY FOR THE VIOLATION OF SAID ORDINANCE. PASSED SEP-TEMBER 4, 1923; APPROVED SEPTEMBER 6, 1923; AMENDED JANUARY 19, 1925; AMENDED SEPTEMBER 21, 1925; AMEND-21, NOVEMBER ED 1927;AMENDED AUGUST 6, 1928; AMENDED OCTOBER 15, 1928.

THE COMMON COUNCIL OF THE CITY OF ANN ARBOR, OR-DAIN:

That sections one (1), two (2), three (3), four (4), five (5), and six of an ordinance entitled, An ordinance to amend an ordinance entitled, "An ordinance regulating, restricting and districting the location of residences, trades, industries, businesses and the location of buildings designed for specified uses, and establishing the boundaries of districts for the said purposes; establishing height and area districts; regulating and determining the area of yards, courts and other open spaces surrounding

buildings, to regulate and limit the density of population; providing for the establishing of set back lines and providing a penalty for the violation of said ordinance. Passed September 4, 1923; approved September 6, 1923; amended January 19, 1925; amended September 21, 1925; amended November 21, 1927; amended August 6, 1928; amended October 15, 1928," be and the same hereby are amended to read as follows and sections six A (6A) and six B (6B) included in the terms of said ordinance.

SECTION 1. Definitions.

For the purpose of this ordinnce certain terms and words are herewith defined as follows:

Words used in the present tense include the future; words in the singular number include the plural, and words in the plural number include the singular; the word "building" includes the word "Structure;" the word "Shall" is mandatory and not directory. Any words not herein defined shall be construed as defined in the Housing Code of Michigan, Act 167, Public Acts of 1917, and amendments thereto.

Accessory Building: A subordinate building or portion of main building the use of which is incidental to that of the main building.

Apartment House: See "Multiple Dwelling."

Boarding House: A building, other than a hotel, where lodging and meals for five or more persons are served for compensation.

Building: A structure having a roof supported by columns or walls for shelter, support or enclosure of persons, animals or chattels; and when separated by division walls from the ground up, and without opening, each portion of such building shall be deemed a separate building.

Court, Inner: An open unoccupied space enclosed on all sides by walls, or by walls and a lot line.

Court, Outer: An open unoccupied space on the same lot with a building. opening upon a street, alley, yard or setback.

Court, Height of: The vertical distance from the lowest level of such court to the highest point of any bounding wall.

Court, Length of Outer: The mean horizontal distance between the open and closed ends of the court.

Curb Level: The mean level of the established curb in front of the building. Where no curb has been established the city engineer shall establish such curb level for the purpose of these regulations.

Dwelling, Private: A building occupied by but one (1) family alone.

Dwelling, Two-family: A building occupied by but two (2) families alone.

Dining Room, Public: A building where meals are served at tables for compensation.

Dwelling, Multiple: A building or portion thereof in which persons dwell otherwise than as a private dwelling or two-family dwelling or as a fratenity or sorority.

Fraternity or Sorority: A building owned by a general or local chapter of some regularly organized college fraternity or sorority, or by or on its behalf by a building corporation or association composed of members or alumni thereof, and occupned by members of the local chapter of such fraternity or sorority, as a place of residence.

Garage, Private: A garage with capacity for not more than four (4) steam or motor driven vehicles, for storage only, for private use, not more than two spaces of which may be rented to persons not occupants of the premises.

Garage, Public: Any building or premises used for housing or care of more than four (4) steam or motor driven vehicles, or where any such vehicles are equipped for operation, repaired, or kept for remuneration, hire or sale.

Height of Building: The vertical distance measured from the curb level to the highest point of the roof surface if a flat roof, to the deck line of mansard roofs, and to the mean height level between eaves and ridge of gable, hip and gambrel roofs. For buildings set back from the street line, the height of the building may be measured from the average elevation of the finished grade along the front of the building provided its distance from the street line is not less than the height of such grade above the established curb level.

Hotel: A building occupied as a more or less temporary abiding place of individuals, who are lodged with or without meals, in which as a rule the rooms are occupied singly for hire, in which provision is not made for cooking in any individual apartment, and in which there are more than twenty-five (25) sleeping rooms, a public dining room for the accommodation of at least twenty-five (25) guests, and a general kitchen.

Lodging House: A building, other than a hotel, where lodging for five (5) or more persons is provided for compensation.

Lot: Land occupied or to be occupied by a building and its accessory buildings and including such open spaces as are required under this ordinance, and having its principal frontage upon a public street or officially approved place.

Lot, Corner: A parcel of land under common ownership not more than 65 feet wide at the intersection of two (2) or more streets, intersecting at an angle not exceeding one hundred and thirtyfive (135) degrees.

Lot, Interior: A lot other than a corner lot.

Lot, Through. An interior lot having a frontage on two streets.

Lot, Lines: The line bounding

a lot as defined herein.

Non-Conforming Use: A building or premises occupied by a use that does not conform with the regulations of the use district in which it is situated.

Place: An open, unoccupied space dedicated to purposes of access for abutting property.

Setback: The minimum horizontal distance between the front line of the building, excluding steps and unenclosed porches and the street line.

Stable, Private: A stable with a capacity for not more than two horses.

Story: That portion of a building above the basement included between the surface of any floor and the surface of the floor next above it, or if there be no floor above it, then the space between such floor and the ceiling next above it.

Story, Half: That portion of a building in "A" Height District, between the eaves and ridge lines of a pitched roof, which may or may not be used for tenant purposes.

Street: A public thoroughfare more than twenty (20) feet wide.

Structural Alterations: Any change in the supporting members of a building, such as bearing walls, columns, beams or girdles, excepting such alterations as may be required for the safety of the building.

Yard, Depth of Rear: The minimum horizontal distance between the rear line of a building, other than a building for an accessory use, and the center line of the alley, where an alley exists, otherwise the rear line.

Yard, Rear: A space, unoccupied except by a building of accessory use as hereinafter permitted, extending for the full width of the lot between a building other than a building of accessory use and the rear lot line. Yard, Side: An open unoccupied space on the same lot with the building between the building and the side lot line and extending from the street line to the rear lot line.

SECTION 2. Use District and Height and Area Regulations.

In order to regulate and restrict the location of residences, trades, industries, businesses and the location of buildings designed for specified uses and in order to regulate and limit the height and bulk of buildings hereafter erected or altered, and to regulate and determine the area of yards, courts and spaces surrounding other open buildings, and to regulate and limit the density of population; the City of Ann Arbor is hereby divided into districts, of which there shall be five (5) known as:

"A" Residence District.

"B" Residence District.

"C" Local Business District.

"D" Commercial District.

"E" Commercial and Industrial District.

The City of Ann Arbor is hereby divided into five districts as shown upon the map attached hereto and being made a part of this ordinance, being designated as the "Map of the City of Ann Arbor, Michigan, Showing Districts for Use and Height and Area Regulations, as passed by the Common Council, Sept. 4, 1923, and amended by the terms hereof, and by the amendments of Jan. 19, 1925, Sept. 21, 1925, Nov. 21, 1927, Aug. 6, 1928, Oct. 6, 1928, said map and all notations, references and other information thereon shall be as much a part of this Ordinance as if the matters and information set forth by the said map were fully described herein.

Except as hereinafter provided no building shall be erected or altered nor shall any bulding or premises be used for any purpose other than is permitted in the Use District in which such building or premises is located; neither shall any building be erected or altered except in confromity with the regulations herein established for the Height and Area District in which such building is located. No lot area shall be so reduced or diminished that the yards or open spaces sall be smaller than prescribed by this Ordinance.

SECTION 3. "A" Residence District.

In the "A" Residence District shall be that portion or those portions of the City of Ann Arbor in which no building or structure shall be erected, constructed or maintained which shall be used for or designed or intended to be used for any purpose other than that of residence purposes and municipal buildings and churches. Excluded— Hotels, buildings designed for more than two families, and with more than two kitchens.

Private garages and the usual outbuildings may be located or maintained appurtenant to any building lawfully within the boundaries of the district here specified, provided that the line of said building shall not be nearer the street line than the building line in said district, and provided further that no such private garage shall be located or maintained on the front half of any vacant lot.

In the "A" Residence District the height of buildings, the minimum dimensions of yards and courts, and the minimum lot area per family shall be as follows:

Height: No building shall exceed thirty-five feet (35) feet nor be of more than two and one-half  $(2\frac{1}{2})$  stories.

Rear Yard: There shall be a rear yard having a minimum depth of twenty-five (25) feet.

Side Yard: There shall be a side yard not less than five (5) feet in width on each side of a building, provided, however, that on a lot of less than forty (40) feet and which is separate and distinct from adjacent lots and is included in a plat of record at the time of the passage of this ordinance, there shall be a side yard on one side of a building of not less than five (5) feet in width and a side yard on the other side of not less than three (3) feet.

Outer Court: The minimum width of an outer court shall be, for a one (1) story building, five (5) feet; for a two and one-half  $(2\frac{1}{2})$  story building, six (6) feet.

Inner Court: The least dimensions of an inner court shall never be less than twice the minimum width prescribed by this section for an outer court. The length of the court shall never be greater than five times its width.

Lot Area per Family: Every building hereafter erected or altered which is located in the "A" Residence and "A" Height area District shall provide a lot area of not less than five thousand (5,000) square feet, per family.

SECTION 4. "B" Residence District.

In the "B" Residence District no building or premises shall be used and no building shall be hereafter erected or altered, unless otherwise provided in this ordinance, except for the one or more following uses.

1. Any use permitted in the "A" Residence District.

2. Multiple Dwellings.

3. Boarding and Lodging Houses, public dining rooms.

4. Institutions of an education, religious, philanthropic or eleemosnynary nature, not including penal or correctional institutions.

5. Accessory buildings and uses customarily incident to any of the above uses when located on the same lot and not involving a retail business.

In the "B" Residence District the height of buildings, the minimum dimensions of yards and courts, and the minimum lot area per family shall be as follows: Height: No building shall exceed forty-five (45) feet nor be of more than three (3) stories.

Rear Yard There shall be a rear yard having a minimum depth of twenty-five feet; provided that the rear yard shall be increased in depth by four feet for each additional story of the building above three (3) stories.

Side Yard There shall be a side yard of not less than five (5) feet in width on each side of a building, provided however, that on a lot having a width of less than forty (40) feet and which is separate and distinct from adjacent lots and is included in a plat of record at the time of the passage of this ordinance, there shall be a side yard on one side of a building of not less than five (5) feet in width. A side yard shall in no case be less than one and one-half  $(1\frac{1}{2})$  inches wide for each foot of building height, nor less than one and onehalf  $(1\frac{1}{2})$  inches wide for each foot of building length.

Outer Court: The minimum width of an outer court shall be for a one (1) story building, five (5) feet; for a two (2) story building, six (6) feet; for a three (3) story building, seven (7) feet; and shall be increased two (2) feet in width for each additional story above three (3) stories. The length of the court shall never be greater than five times its width.

Inner Court: The least dimension of an inner court shall never be less than twice the minimum width, prescribed by this section for an outer court. The length of the court shall never be greater than five (5) times its width.

Lot Area Per Family: Every building hereafter erected or altered which is located in the "B" Residence and "B" Height and Area District shall provide a lot area of not less than one thousand (1000) square feet, per family.

SECTION 5. "C" Local Business District.

In the "C" Local Business District, no building or premises shall be used, and no building shall be erected or structurally altered which is arranged, intended or designed to be used for other than a use permitted in "A" and "B" residence districts or for one or more of the following uses:

1. Gasoline, or other motor fuel filling station.

2. Bank, Office, Studio, Telephone Exchange, Sales Office, Fire Station.

3. Retail Stores, Restaurants, Theatre, Moving Picture Theatre.

In the "C" Local Business District, the height of buildings, the minimum dimensions of yards and courts, and the minimum lot area per family shall be as follows:

Height: No building shall exceed fifty-five (55) feet nor be more than four (4) stories.

Rear Yard: There shall be a rear yard having a minimum depth of twenty-five (25) feet for residences built in this district, provided than the rear yard shall be increased in depth by four (4) feet for each additional story of the building above three (3) stories.

Side Yard: A side yard, if provided, shall meet the requirements of the "B" Residence District.

Outer Court: The least dimension of an outer court shall be not less than five (5) feet wide, nor less than two (2) inches wide for each foot of height of such court, nor less than two (2) inches wide for each foot of length of such court from the enclosed end.

Inner Court: The least dimension of an inner court shall be not less than six (6) feet wide, nor less than two (2) inches wide for each foot of height of such court, nor shall its area be less than twice the square of its required least dimension.

Lot Area Per Family: Every residence building hereafter erected or altered shall provide a lot area of not less than twelve hundred fifty (1250) square feet per family.

SECTION 6. "D" Commercial District.

In the "D" Commercial District, all buildings and premises except as otherwise provided in this ordinance may be used for any use permitted in the "A" and "B" Residence District and "C" Local Business District or for any other use except the following:

1. Bakery (employing more thn five persons, excluding sales and office force).

2. Blacksmith or horseshoeing shop.

3. Bottling works.

4. Building material storage yard.

5. Carting, express, hauling or storage.

6. Contractors plant or storage yard.

7. Coal, coke or wood yard.

8. Cooperage works.

9. Dyeing or cleaining works (employing more than [5] persons).

10. Ice plant or storage house of more than eight (8) tons capacity.

11. Laundry (employing more than five [5] persons).

12. Livery stable.

13. Lumber yard.

14. Machine shop.

15. Milk distribution plant.

16. Planing mill.

17. Stone yard or monumental works.

18. Storage warehouse.

19. All uses excluded from the "E" Commercial and Industrial District.

20. Any kind of manufacture or treatment other than the manufacture or treatment of products clearly incidental to the conduct of a retail business conducted on the

#### premises.

In the "D" Commercial District the height of buildings, the minimum dimensions of yards and courts, and the minimum lot area per family shall be as follows:

Height: No building shall exceed one hundred and twenty-five (125) feet or ten (10) stories.

Rear Yard: A rear yard, if provided, shall have a minimum depth of twenty-five (25) feet for residences built in this district; provided that the rear yard shall be increased in depth by four (4) feet for each additional story of the building above three (3) stories.

Side Yard: A side yard, if provided, shall meet the requirements of the "B" Residence District.

Outer Court: The least dimension of an outer court shall be not less than five (5) feet wide, nor less than two (2) inches wide for each foot of height of such court, nor less than two (2) inches wide for each foot of length of such court from the enclosed end.

Inner Court: The least dimension of an inner court shall be not less than six (6) feet wide, nor less than two (2) inches wide for each foot of height, of such court, nor shall its area be less than twice the square of its required least dimension.

Lot Area Per Family: Every building hereafter erected or altered shall provide a lot area of not less than six hundred and twenty-five (625) square feet per family.

SECTION 6A. "E" Commercial and Industrial District.

In the "E" Commercial and Industrial District all buildings and premises except as otherwise provided in this ordinance may be used for any use permitted in the "D" Commercial District or for any use except the following:

- 1. Abattoirs.
- 2. Acetylene gas manufacture.
- 3. Acid manufacture.

4. Ammonia, bleaching powder or chlorine manufacture.

5. Arsenal.

6. Asphalt manufacture or refining.

7. Blast furnace for reduction of ore.

8. Dyestuff manufacture.

9. Fat rendering.

10. Fertilizer manufacture.

11. Fireworks or explosive manufacture or storage.

12. Fish smoking or curing.

13. Glue, sizing or gelatine manufacture.

14. Gunpowder manufacture or storage.

15. Incineration or reduction of garbage, dead animals, offal or refuse.

16. Lampblack manufacture.

17. Petroleum refining or storage.

18. Potash works.

19. Pyroxyline manufacture.

20. Rolling mills.

21. Smetlers.

22. Soap manufacture.

23. Storage or baling of scrap paper, iron, bottles, rags or junk, except scrap naturally accuring and incidental to an industrial institution.

24. Sulphuric, nitric or hydrochloric acid manufacture.

In the "E" Commercial and Industrial District the height of buildings, the minimum dimension of yards and courts, and the minimum lot area per family shall be as follows:

Height: No building shall exceed seventy-five (75) feet or six (6) stories.

Side Yard: A side yard, if provided shall not be less than five (5) feet in width.

Outer Court: The least dimension of an outer court shall be not less than five (5) feet wide, nor less than two (2) inches wide for each foot of height of such court, nor less than two (2) inches wide for each foot of length of such court from the enclosed end.

Inner Court: The least dimension of an inner court shall be not less than six (6) feet wide, nor less than two (2) inches wide for each foot of height of such court, nor shall its area be less than twice the square of its required least dimension.

SECTION 6B. Height and Area District Exceptions.

The foregoing requirements in the height and area districts shall be subject to the following exceptions and regulations:

Height:

(a) In the "A" and "B" Height and Area Districts, public or semipublic buildings, hospitals, sanitariums, or schools may be erected to a height not exceeding seventy-five (75) feet, when set back from all lot lines not less than one-half ( $\frac{1}{2}$ ) foot for each foot such buildings exceed thirty-five (35) and fifty-five (55) feet, respectively, in height, this to be in addition to the required open spaces for these districts.

(b) Private and two-family dwellings in the "A" Height and Area District may be increased in height by not more than ten (10) feet when two (2) side yards of not less than ten (10) feet each are provided. Such dwellings, however, shall not exceed three (3) stories in height. Buildings and structures in "B" Residence District may be inceased under like circumstances not to exceed sixty-five (65) feet in height.

(c) Parapet walls not exceeding four (4) feet in height, chimneys, cooling towers, elevator bulkheads, fire towers, gas tanks, grain elevators, penthouses, stacks, stage towers or scenery lofts, sugar refineries, tanks, water towers, radio towers, ornamental towers, monuments, cupolas, domes and spires, or necessary mechanical appurtenances may be erected as to their height in accordnce with existing or hereafter adopted ordinnces of the City of Ann Arbor.

(d) On "through" lots, one hundred (100) feet or less in depth, the height of a building may be measured from the curb level on either street. On through lots more than one hundred (100) feet in depth, the height regulations and basis of height measurement for the street pemitting the greater height shall apply to a depth of not more than one hundred (100) feet from that street.

(e) In the "A," "B," and "C" Height and Area Districts, an accessory building not exceeding fifteen (15) feet in height may occupy not more than thirty (30) per cent of the rear yard. Provided, that on corner lots. any building in the rear shall be not less than five (5) feet from the rear lot line.

Area:

(f) For purposes of the area regulations, a two-family dwelling in the "A" and "B" Residence Districts may be considered as one building and occupying one lot.

(g) Buildings on "through" lots and running through from street to street may waive the requirements for a rear yard by furnishing an equivalent open space in lieu of such required rear yard.

(h) In computing the depth of a rear yard or the width of a side yard or outer court for any building where such yard or court opens onto an alley, or street, one-half of such alley or street may be assumed to be a portion of the yard or court.

(i) Every part of a required yard or court shall be open from its lowest point to the sky unobstructed, except for the ordinary projections of skylight above the bottom of such yard or court, and except for the projection of sills, belt courses, cornices and ornamental features not to exceed four (4) inches.

(j) No cornice shall project over the street line more than one ane one-half  $(1\frac{1}{2})$  feet.

(k) On lots of less than five thousand (5,000) square feet in area in a plat of record, or of separate and distinct ownership, at the time of the passage of this ordinance, a single or two-family dwelling may be built; provided the yard requirements of the State Housing Code are met.

(1) On lots of less than eighty (80) feet in depth, in a plat of record, or of separate and distinct ownership at the time of the passage of this ordinance, the rear yard requirements may be reduced to the rear yard requirements of the State Housing Code.

SECTION 6c. This ordinance shall take effect on and after ten days of legal publication.

Your Sewer Committee, to whom was referred the estimate and report of the City Engineer relative to construction of lateral sewers in Lateral Sewer District No. 179, on Cedar Bend Drive, from intersection of Broadway with Cedar Bend Drive southeasterly; District No. 180, all streets in Allmand Heights Subdivision; District No. 182, on Lafayette Road between Highland Road and Lenawee Dr.; District No. 183, Arbor View Blvd. from Wildwood Avenue to Brierwood Street, on Brierwood Street, Linwood Avenue to Arbor View Boulevard, and on Linwood Ave., from Brierwood to the east line of Westwood Hills Addition; District No. 184, all streets in Allmendinger Heights Subdivision south of Pauline Boulevard, has had said matter under consideration and has heard all persons desiring to be heard in the premises, and "our committee is of the opinion that there is necessity for the construction of said lateral sewer and recommends that special taxing or assessment district be fixed by the Common Council upon and against which the construction of said sewer be charged, street intersections excepted, pursuant to the ordinance in such case made and provided. and that resolutions fixing the boundaries of said sewer district be prepared by the City Engineer.

We further recommend that action be deferred on the Vinewood-Geddes District No. 181 and that the City Engineer, City Attorney be requested to negotiate with Mr. Bishop and others for right-of-way.

We further recommend that the plans, specifications and preliminary estimates of cost of the following storm sewers, as approved by the Board of Public Works, be approved: on Davis, Wilder, Hoover and Fifth streets; on Madison Street, Fourth to Sixth streets and Main to First; on Brooklyn Ave., Westminster to Gardner Avenue; on Washington Heights, Valley to Observatory Street; on Pine Ridge, Drain to Maryfield Drive; on Miner Street, Felch Street southerly to angle; on Vinewood Avenue, Wayne Street easterly 230 feet.

We further recommend that the Board of Public Works be instructed to advertise for bids for the construction of said lateral and storm sewers and that the construction of said sewers is hereby deemed and declared to be necessary public improvements.

Your Sewer Committee has estimated cost of storm sewer for ensuing year to be \$26,309.62 and contingencies of \$6,000.00, and we respectfully recommend that the above amount be raised in budget for ensuing year.
