PRESENTATIONS OF PETITIONS AND COMMUNICATIONS.

To the Honorable, the Common Council:

The Board of Fire Commissioners, to whom was referred the matter of plac-

ing and maintaining an equipment for fire purposes at the 6th ward engine house, would respectfully report that they have carefully considered the proposition, and would say that they would be pleased to act favor-ably thereon if it is the pleasure of the council to provide the necessary means. The fire department as at present eqipped and maintained at the central engine house is in excellent condition, able to cope with any ordinary conflagration that may occur in the business and manufacturing portions of our city. The commissioners do not believe it wise to weaken this force in any particular, the greater portion of the property of the city is protected from this point, and the force and equipments must be ample to be efficient.

To comply with the resolution of the council, it is estimated the cost would

be as follows:

The cost of maintaing such a force at that point would be about \$2,250 yearly. It is the unanimous opinion of this board that it would be a wise precaution against fire to place and maintain such a force there, but that the finances of the city are not in a condi-The one great tion to warrant it. necessity of a successful fire de-partment is to reach a fire before it gains headway, and if the commissioners are allowed to make a suggestion, they would propose for the consideration of your honorable body the adoption of some fire alarm system, that would be a great help to the department, and undoubtedly be the means of saving much property in the residence portions of our city remote from the central engine house. Which report was unanimously adopt-
