COUNCIL CHAMBER, ANN ARBOR, March 20, 1898. Regular session.

President Cooley being absent, the Council was called to order by the Clerk.

Roll called. Quorum present.

Absent-Ald. Taylor and President Cooley.

On motion of Ald. Wines, Ald. Fillmore was elected president prostem.

The journal of the last session was approved.

### COMMUNICATIONS FROM THE MAYOR.

CITY OF ANN ARBOR,

MAYOR'S OFFICE, March 9, 1893.

To the Honorable, the Common Council : GENTLEMEN-I'am constrained to return to you without my approval so much of the pro ceedings of your honorable body at its last regular session as relates to the adoption of the following resolution:

By Alderman Martin-

Resolved, That \$698.27 be transforred from contingent fund into street fund, the above. being the amount spent out of street fund at the old cemetery, \$398 27 lor removing dead bodies, and \$300 which has been spent for Burchasing point between Detroit street and Beakes street in the fourth ward.

Adopted as follows:

Nays-Ald Ferguson, O'Mara-2:

Section 172, subdivision eighth, of the city, harter provides as follows: "No transfer charter provides as follows: "No transfer shall be made from one fund to another, except by a three-fourths vote of all the members

The resolution having received only nine votes in the affirmative, it is manifest that the same did not receive a three-fourths vote of all the members of the Common Council elect; for section 70 of the City Charter afore-said expressly provides: that "The legislative authority of the said city of Ann Arbor shall be vested in a common council consisting of the president of said council and two alder-men elected from each ward," that is to say, that, as at present constituted, the common council of the city of Ann Arbor consists of thirteen members

The adoption of the said resolution as declared by the record, being against the exfully refuse my approval thereof. WILLIAM G. DOTY, Mayor.

The question being that the action of the council regarding the transfer of money from Contingent Fund to the Street Fund be sustailed, the mayor's veto notwithstanding, the question was lost, two-thirds of the aldermen elect not voting therefore, by yeas and nays as follows:

Nays-Alas. Fillmore, Ferguson, Kitson, O'Mara-4.

A petition signed by W. F. Stiegelmaier and fourteen other residents and property holders of the city of Ann Arbor, asking that a fire hydrant be placed on the corner of Mary and Benjamin streets, and extend the water main from Packard street to Benjamin street along Mary street.

A petition signed by Charles Dwyer and sixteen other residents and property holders of the city of Ann Arbor, asking that a sidewalk be ordered built on the north side of Catherinestreet from Ingalls street to Thirteenth street.
