Resolved, That the Board of Public Works of this city be and they are hereby directed to prevent the Detroit, Ypsilanti, Ann Arbor & Jackson Electric Railway Company from laying any tracks or otherwise obstructing any part of Huron street or Jackson avenue until said company shall have obtained a legal franchise so to do.

Be it further resolved, that the City Attorney of the city of Ann Arbor, Michigan, be and he is hereby directed to forthwith file a bill in chancery against said Detroit, Ypsilanti, Ann Arbor & Jackson Electric Railway Company enjoining said company from entering upon Huron street or Jackson avenue for the purpose of constructing a railway in any part thereof until said company shall have obtained a legal franchise so to do.

Be it also resolved that the acting Mayor secure such legal aid as in his judgment may be necessary to assist the City Attorney in this matter.

Ald. Brown offered the following amendment:

That the counsel so employed by the acting Mayor be not employed or connected with either road in question.

To the Common Council:
