The quarterly report of Dr. George as city physician was received and placed on file.

To the Common Council of the City of Ann Arbor:

I herewith submit the annual report of my work as city physician for the year 1901-2:

I have attended 40 patients during the year, making 161 house calls and 195 office visits. The total number of both house and office calls for the year were 356. There was a larger proportion of office visits in the last quarter than usual on account of one case of gunshot wound of the finger which needed a daily change of dressings for three months. The total expense to the city was \$92.90. This was for medicine, dressings and ambulance service. One patient with open fracture of the leg was treated at the University hospital four months at no expense to the city. Two other patients were treated at the Homeopathic hospital without any expense to the city.

I have limited the expense account as far as possible to those medicines

which are necessary to relieve human suffering and to cure disease. There are many cases of chronic diseases among the city poor which require constant medication to obtain any relief whatever and to enable the patients to perform their regular duties so that they may at some time become self-sustaining, useful citizens. Two surgical operations were performed during the year, one for the removal of a piece of glass from the foot and the other for the extraction of No. 32 short bullet from the middle finger of the left hand.

There were only three cases of specific diseases among the poor during the year, one of pulmonary consumption and two of mumps. By examination of previous annual reports it will be observed that with a few additions the same patients have been treated by the city physician for a number of years. These people find it very difficult to become self-sustaining on account of misfortune, unnecessary expenditures of money and the liquor habit. In determining those cases worthy of receiving medical service from the city I have acted upon the advice of Mr. Fred Siple, superintendent of the poor, whose long experience in this work has been of great assistance.
