of nearly all clases of labor have been advanced accordingly, we therefore believe that the police of this city are not getting the wages they are justly entitled to and offer the following resolution:

Resolved, that the city clerk communicate with the Michigan Central and Ann Arbor railroad companies relative to taking care of water that is troubling property holders on Traver street. Carried.

Ald. Grose moved to have bridge over M. C. R. R. tracks repaved, etc., which on motion was referred to the city engineer and street committee.

Ald. Johnson moved the reconsidera-

tion of the action taken relative to the report of the police committee. Lost.

By Ald. Hamilton:

Whereas, the city of Ann Arbor has decided to have State street paved from Huron to Monroe streets and have entered into contract with competent parties to construct said pavement; and

Whereas, the tracks of the D., Y., A. A. & J. Ry. Co. have been constructed along South State street and at the intersection of William and State streets and North University avenue and State street on such rails and upon such foundation as prohibits the laying of said pavement; now therefore, be it

Resolved, that the said railway company be notified, requested and directed to place a gurder grued rail seven inches high upon a concrete foundation, and steel ties on the corner of William and State streets, and on North University avenue and State street, and on State street from the north line of South University avenue to the center of Monroe street, within ten days after the service upon the said railway company of a copy of this resolution. And in case of default thereof, then the city marshal and the street commissioner be and they are hereby directed to remove the tracks of said railway company from that portion of the streets hereinbefore menti ned.
