Gentlemen: I wish to call your attention to the property owned by the late Mrs. Kinne upon the Boulevard. I understand that this property is adjacent to the property recently purchased by the city for park purposes and thinking that the same may be desirable to complete the proposed park, I write you to suggest that the matter be referred to the Park Committee to make an investigation and report the matter back to the Council at an early date.

I also call your attention to the small bill of Asa Allen for services as special patrolman and in reference thereto will say that he was regularly appointed by me as Mayor, that he performed the services and is entitled to his pay, and I hope the necessary action will be taken by you to enable him to receive what is his due. will find ample authority in the charter for the appointment. At the time of Mr. Allen's appointment I had in mind your recommendation in reference to not appointing him again, but that is a matter that rests solely with me; I decided to reserve the right given me by the charter and make the appointment, and shall do so again whenever I think the interests of the city demand such action.

By virtue of the authority in me vested by the charter of said city, I hereby nominate and appoint Dr. Thomas B. Cooley a member of the

Board of Health of said city, said appointment to take effect September 1 next, and respectfully ask that said nomination be confirmed.
