COMMUNICATIONS.

To the Common Council:

I would respectfully recommend that an appropriation of \$100 be made for the taking of the City census of Ann Arbor. I would recommend that Mr. Glen V. Mills be employed to do this work under the supervision of the City Clerk.

The State Census gives Ann Arbor a population of 14,599, a gain of only

90 in the last four years. The gain in the previous ten years was 5,078 and the United States census Bureau estimated the population of Ann Arbor this year at over 16,000. I would recommend that the appropriation be made at this time for two reasons: That the work can now be done at the minimum of expense as Mr. Mills is just beginning a canvas for his City and student directories.

2nd: With the showing that could be made with a census according to the plans outlined, the correctness of which could be quickly verified by the state, a forcible demand could be made that the state correct its census before it is published in book form.

The giving out to the public that Ann Arbor had ceased to grow, that it has become stagnant, that it is falling behind its sister cities in the state, greatly injures the city and has a tendency to re-

tard its growth. The tax payers would undoubtedly get back immediately the money invested by the opportunity afforded to check the school census, each person between five and twenty gained being worth \$1.50 to the City in the state division of primary school funds.

That the city would show a large gain over the state census figures is indicated by the fact that during this month Mr. Mills made a canvass of the first ward and secured 3,068 names, or 400 more than the state census gives the ward and he asserts that at least 100 more names will be found in the ward by checking the former street directory. This gain if kept up through the city would mean a population of 17,500.
