Ann Arbor, Mich., Jan. 16, 1905. To the Honorable the Common Councl of the City of Ann Arbor.

Gentlemen:—At your meeting on Jan. 9, the following resolution was adopted: "Resolved, that the fire commission and the fire committee be requested to make an investigation as to water supply and report at the next meeting of the Council. The Ann Arbor Water Company bill to be then considered."

In accordance with the above resolution we have investigated the question and believe we did not have the pressure we were entitled to on the morning of Dec. 31, 1904, at the High school fire. The only supply furnished was from the reservoir. The contract with the Ann Arbor Water Company entities the city to direct pressure from the pumps in case of emergency. We did not have this.

We believe this company should be requored to put their plants in share to carry out the provisions of this contract.

It is possible that a few more hydrants, where a large fire could occur, would be advantageous.

Sho ld another fire occur similar to the high school fire, we would find ourselves in exactly the same situation we were in at that fire.

As soon as weather conditions are favorable we will cause a test to be made and report our findings to your homorable body.
