To the Council: Gentlemen—Your license committee have had the application of William Corson for saloon license under consideration, and find that it complies with the ordinance, and we recommend that upon the filing of the proper bonds license be issued to him.

Your committee respectfully call attention to the express agreement executed, filed with and made a part of each application, with the understanding that if a license is granted it will be in all respects subject to revocation in accordance with the ordinance passed by the common council, April 19th, 1909. We recommend that in order to impress upon the minds of those to whom saloon licenses have been granted that the provisions aforesaid will be

enforced, the City Clerk mail each and every one of them a copy of the express agreement and this part of report.
