To the Board of Public Works, Gentlemen:

I submit the following preliminary estimate of the cost of grading Medallion-st. Plans and specifications are on file in my office.

To the Board of Public Works, Gentlemen:

In regard to the cost and location of drinking fountains which was referred to me, I beg leave to make the following report: I have gone over the several locations recommended by the common council with Alderman Graf and I would respectfully recommend that the drinking fountains be located as follows: The southeast corner of Ashley and Washington-sts., in front of the American House; the southeast corner of Main and

Huron-sts., on Huron-st.; in front of the Elks' Temple on S. Main-st. or on the northwest corner of William and S. Main-sts.; the south side of Liberty-st. just west of State-st.; the northwest corner of E. University and S. University aves.; the northwest corner of S. State-st. and Packard-st. I placed the cost of each fountain at \$100.00 each, some will cost more and some will cost less, but the average, I believe, will be approximately \$100.00.
