A. Sauer Company, its successors and assigns, Provided, however that said permission is given subject to the right of the city to remove said track at such time as it shall deem it advisable so to do and the permission herein given shall not give said C. A. Sauer Company, its successors or assigns any right of any kind in and to that portion of the said street to be used aforesaid.
