To the Council: Gentlemen—Your Sewer committee has had the following matters under consideration and recommend, that sanitary sewers be constructed as follows: On Eber White boulevard and Woodbridge boulevard; on Buchanan ave., from Liberty st. to Elder boulevard, and on Elder boulevard, from Eber White boulevard to Buchanan ave.; on Lincoln st., from Fourth ave to Main st. and on John K. ave., from Main to Third sts.

We further recommend that Assessor's plats be made of all unplatted property within the city, now being sold in lots.
